

# Descendants of Daniel Everitt

---

## Generation 1

1. **DANIEL<sup>1</sup> EVERITT** . He died in 1807. He married **RACHEL UNKNOWN**.

Notes for Daniel Everitt:

The Daniel Everitt who married Rachel and who died 1807 might be the Daniel Everitt listed for a book debt in the Accounts section of the Last Will and Testament of John Everitt of Bethlehem Twp., Hunterdon Co., NJ, written 29 May 1756 and proved 12 Jul 1761 (NJ State Archives: 527J). It is likely Daniel was related to John Everitt, but it is not known how. The identity of Daniel's wife, Rachel is also unknown, but she may have been the daughter of Joseph Howell of Kingwood Twp., Hunterdon Co., NJ, whose Last Will and Testament, written 11 May 1773 and proved 23 Sep 1774, names, among others, a daughter Rachel Everitt (Honeyman, "Calendar of Wills: 1771-1780," p.259).

The Last Will and Testament of Daniel Everitt, written 30 Oct 1804 and proved 28 Oct 1807, locates Daniel in Kingwood Twp., Hunterdon Co., NJ and names wife Rachel, and children Daniel, Moses, Mary (wife of John Lake), Rachel (wife of Darius Everitt), Sarah (wife of Cornelius Coolbough), and Elizabeth (wife of John Kemple). Witnesses were Jonathan Roberson, Joshua Opdycke, and Richard Opdycke, Jr. Executors were Richard Opdycke, Esq. and Thomas Lequear (NJ State Archives, 2248J).

Daniel Everitt's property is surely that mentioned in the 1766 mortgage deeds of Joseph Everitt, who was John Everitt's son (Bk.1, pp.17-19). Joseph's land bordered Richard Opdike, Malakiah Bonham, Abraham Gray (Daniel Everitt made the 1782 Inventory for Abraham Gray), and Thomas Herbert (deacon of the Kingwood Baptist Church). Further, Richard Opdycke and Daniel Everitt were witnesses to the 3 May 1803 deed transferring part of the Kingwood Twp., Hunterdon Co., NJ property of Ezekiel Everitt (John Everitt's grandson), then of Middletown Twp., Bucks Co., PA, to Francis Robinson (Bk.14, p.281). Also, records of the Kingwood Baptist Church contain a 3 May 1790 entry for the exclusion of Richard Opdyke, and Dan'l Everitt and Rachel Everitt (D'Autrechy, "Some Records of Old Hunterdon County: 1701-1838," p.90). It should also be noted that Daniel and Rachel Everitt's son, Moses, married Hannah Rittenhouse and in 1815 Moses purchased property from Cornelius Polhemus, becoming involved in law suits filed in the 1820s by the heirs of Cornelius Polhemus. (A witness to the 1756 Last Will and Testament of John Everitt was a Cornelius Polhemus.)

Notes for Rachel Unknown:

Rachel may have been the daughter of Joseph Howell.

Daniel Everitt and Rachel Unknown had the following children:

- i. **DANIEL<sup>2</sup> EVERITT**. He died on 05 Aug 1818 in Kingwood Twp., Hunterdon Co., NJ. He married Sarah L. Hartpence on 11 Jun 1795. She was born on 29 Mar 1775 in Hunterdon Co., NJ. She died on 24 Oct 1836 in Trenton, Mercer Co., NJ (Old School Baptist Cemetery, Locktown, Hunterdon Co., NJ).

Notes for Daniel Everitt:

Daniel and Sarah had no children. In his Last Will and Testament, written 19 Oct 1815 and proved 29 Aug 1818, Daniel Evritt of Kingwood Twp., Hunterdon Co., NJ names wife Sarah, nephew John Hartpence (son of Thomas Hartpence), Uzenia Potts, Negro man Toni, Daniel Evritt Hartpence (son of James Hartpence), Daniel Evritt Coolbough (son of Cornelious Coolbough). Daniel also makes bequests to "the surviving children of each of my four sisters": Mary Lake, Rachel Evritt (deceased), Sarah Coolbough, and Elizabeth Kemple (Wills, Vol. 3-6: 1815-1838).

Notes for Sarah L. Hartpence:

After the death of Daniel Everitt, Sarah married Thomas Lequear (1762-1846) on 18 Sep 1819 (Rev. David Bateman).

- ii. **MOSES EVERITT**. He married **HANNAH RITTENHOUSE**. She was born in 1784.

Notes for Moses Everitt:

Children of this marriage are as yet unknown.

## Generation 1 (con't)

Notes for Hannah Rittenhouse:

As histories of the Rittenhouse family demonstrate, the Rittenhouses had close ties to the Everitts. Hannah Rittenhouse's father, Joseph, was the son of Lott Rittenhouse and Hannah Higgins. Lott's brother, William, married Rebecca Harned, and their daughter, Rebecca, married Amos Bonham. Amos and Rebecca Bonham's son, Uriah, married Elizabeth Everitt, daughter of Ezekiel and Mary Everitt. Amos and Rebecca Bonham's son, Ambrose, married Anna Lair, and their son, John Bonham, married Rebecca Everitt, daughter of Ezekiel and Catherine Everitt.

William and Rebecca Rittenhouse's son, Daniel, married Jane Cartright, and their daughter, Catherine, married Ezekiel Everitt Jr., son of Ezekiel and Mary Everitt.

William and Rebecca Rittenhouse's son, Benjamin, married Elizabeth Fowler, and their son, William, married Sarah Emans and had a daughter, Nancy Ann, who married Epenetus Everitt, the grandson of Ezekiel and Mary Everitt. Benjamin and Elizabeth's son, Nathaniel, married Nancy Thatcher, and their daughter, Margaret, married Elijah Everitt.

- iii. MARY EVERITT. She married JOHN LAKE.
- iv. RACHEL EVERITT. She died before 1815. She married DARIUS EVERITT. He died in 1822.

Notes for Darius Everitt:

Tax records place Darius Everitt in Kingwood Twp., Hunterdon Co., NJ from 1778 to 1780. The following year, 1781, Bucks Co., PA tax records list Darius (and his brother, Ezekiel) as living in Tinicum Twp. (Each is listed as Everhart.) The same records show that Darius moved to Upper Makefield Twp. between 1784 and 1785. Darius Everitt's first census appearance is on the 1790 Bucks Co., PA census, where he appears as Darius Everard. His household contains 8 members: 2M 16+, 4M -16, and 2F. This number of household members suggests two families. The identity of the other family is unknown. The possibility exists, however, that Darius's father, John, may have been living with Darius. John Everitt died 1808 in Kingwood Twp. The other possibility is that Darius's father-in-law was living with him. (None of Darius's known sons would have been married by 1790.)

On 15 Apr 1794, Darius Everitt purchased 150 acres of land in Amwell Twp., Hunterdon Co., NJ, from Isaiah and Miriam Quimby. The deed (Bk.11, p.326) describes Darius as formerly of Bucks Co., PA, but at the time of the sale as of Amwell Twp. A witness to the deed was Ezekiel Everitt, surely Darius's brother.

Later deeds identify Darius's wife as Rachel, as do other documents. Rachel was the daughter of Daniel and Rachel Everitt, and may have been Darius's cousin. Rachel died before 1815, and Darius remarried Sarah (Pettit) Kelley on 18 May 1816. (Sarah's first marriage was to Daniel Kelley on 5 Oct 1797. Daniel Kelley died 1814.) The marriage was announced in the 27 May 1816 edition of the "True American": "On the 18th Instant by John Cavanaugh, esq., Mr. Darius Everitt to Mrs. Sarah Kelly, all of Amwell" (p.3).

Darius Everitt's Last Will and Testament, written 8 Jul 1821 and proved 22 Jun 1822, states he resided in Kingwood Twp., Hunterdon Co., NJ and identifies his wife as Sarah, and his children as Ezekiel, Daniel, Asa, Enos, Moses, Sarah, Fanny, and Elizabeth. Darius writes that the "most considerable part of my Real estate lies in the county of hampshire in the State of Virginia," and states that he owned two adjacent tracts of land, one consisting of 500 acres and the second of 214 acres. Darius indicates that Asa, Enos, and Moses were living on this Virginia land, and then directs that the land be divided and given to his three sons. To his wife Sarah, Darius gave his Kingwood Twp. real estate, consisting of 90 acres.

### Generation 1 (con't)

Sons Ezekiel and Daniel were given only \$1.00 each, for they had earlier received money from their father. Darius's daughter, Sarah, was "infirm" and money was to be set aside for her "decent support during her natural life." The estate left to Darius's wife would be shared with his daughters. Three executors were named: sons Ezekiel and Daniel, and George Wanamaker (Bk.4, p.1).

Darius's wife, Sarah, died 1841, and the Court granted administration of Darius's estate to George Wanamaker. Citing Darius's Will, the Court ruled that the estate was to be sold after his wife Sarah's death. And since Ezekiel Everitt and Daniel Everitt were no longer residing in NJ, the sale was to be conducted by Darius's third appointed executor, George Wanamaker. The Letter of Administration states that Sarah Everitt was "late of the County of Miami in Ohio" (Bk.4, p.58). Apparently, at some point Sarah moved to Ohio to live with her son, Daniel, who was living in Miami Co., OH. Daniel married Rachel Pettit. If and how Sarah and Rachel were related is unknown. George Wanamaker, who had married Darius's daughter, Fanny, sold Darius's estate to William Hann on 2 May 1843 (Bk.80, p.324).

2. v. SARAH EVERITT was born on 30 Apr 1782. She married CORNELIUS COOLBAUGH. He was born on 19 Nov 1762 in Hunterdon Co., NJ. He died on 22 Sep 1841 in Bradford Co., PA.
- vi. ELIZABETH EVERITT. She married JOHN KEMPLE.

### Generation 2

2. SARAH<sup>2</sup> EVERITT (Daniel<sup>1</sup>) was born on 30 Apr 1782. She married CORNELIUS COOLBAUGH. He was born on 19 Nov 1762 in Hunterdon Co., NJ. He died on 22 Sep 1841 in Bradford Co., PA.

Notes for Sarah Everitt:

Data entered here for Cornelius and Sarah Coolbaugh come principally from Edward Coolbaugh Hoagland's 1938 "The Coolbaugh Family in America" (pp.16-17, 23).

She died on 26 Feb 1884 in Scranton, Lackawanna Co., PA (Dunmore Cemetery, Lackawanna Co., PA).

- iii. DEBORAH F. COOLBAUGH was born on 20 Aug 1817. She married RICHARD S. STAPLES.

4. **DANIEL EVERETT<sup>4</sup> COOLBAUGH** (Cornelius<sup>3</sup> Jr., Sarah<sup>2</sup> Everitt, Daniel<sup>1</sup> Everitt) was born on 20 Feb 1814. He died on 11 Oct 1874 (Dunmore Cemetery, Lackawanna Co., PA). He married Mary Annette Snyder, daughter of Joseph Snyder and Susan, on 17 Jan 1839. She was born on 24 Jul 1816. She died on 26 Feb 1884 in Scranton, Lackawanna Co., PA (Dunmore Cemetery, Lackawanna Co., PA).

Daniel Everett Coolbaugh and Mary Annette Snyder had the following children:
