situate in the Township of Ainsworth County of Addington in the District  
containing by advertisement two hundred acres of land both more or less  
from the west part of lot number twenty nineteen in the fourth Concession of the said  
Ainsworth Township together with the forty foot road between lots number nineteen and twenty which  
said two hundred acres of land are bounded and bounded as follows It is now  
as follows that is to say commencing where a post has been planted at the south west angle of  
the said lot nineteen said post being twenty four degree one hundred  
minutes one hundred and five links from the south more or less to the allowance in said  
a the side of said concession thence with due few degrees and a half west thirty three chains  
twenty four links more or less to the south between lot number eighteen and nineteen then south  
thirty three and a half degrees east twenty six chains twenty nine links to the fourth part of  
the length of said concession then north forty four degrees and a half east sixteen chains  
to the corner between lots number nineteen and twenty then south twenty four and a half degrees  
east thirty eight chains and eight links to the south side of the allowance made for road  
in the front of said concession then north forty four and a half degrees east fourteen chains
