# Bibliography of Julius J. Marke: 1949–2003\*

Spanning the work of more than a half-century, this remarkably lengthy listing of titles not only reflects the wide-ranging interests of Professor Julius J. Marke, but also chronicles the many issues facing the law library profession from the late 1940s until well into the computer age. In addition, the names of his many collaborators make up a veritable "who's who" of AALL history.
