and her heires for ever And furthermore I the said Abraham do by this my last  
will and testamant devise give and bequeath unto the said Mary all other my lands  
tenementys and hereditamentys what soevre and whiche soevre to haue and to hold  
the same to her the said Mary, and her heires for ever And also give and bequeath  
to the said Mary Bownd my wife all and singular my goods Chattell Chattell platt  
hewell ready money myloun & of hys and household stuffe and other thinges whiche shal be  
and of this my last will and testamant I do make ordaine and appoynt the said  
Mary Bownd my wife my sole and onely Executoris And I do hereby make a chal-  
leng and make void all former and other wills what soevre Anno Domini Mille six hundred & treynt  
the said Abraham have hereunto subscrivid my hand and set to my seal and haue pub-  
lisched this my will and testamant the daye and year first above-

John Lake Twenty Shillings in letellour of all such want and pouer as he can claime of  
my estate by the custome of the Cittie of London, or otherwise, The remaynder of my estate I  
give to my loyall wifte Hester Lake, who I heartily appoynte to be Executrye of this my will  
and my father Edward Lake Executor, And I hereby revoke all former wills, In witness  
whereof I haue hereunto set my hand and seal, the day and year above written, John Lake  
Sealed and delivered as his last will and testament in the presence of Hermannus Michalib  
Edmund Lake, my g[od]d[son] Higley No: 3 pub[li]c
